

Regulation of the 4th International Junior Piano Competition

Samson François" - 2025

Article 1 - Organizer and purpose of the competition

The organizer of the Competition entitled "Samson François International Junior Piano Competition" (hereinafter referred to as "the Competition") is the Association "Le piano en Liberté" (hereinafter referred to as "the Association"), an association governed by the French law of July 1, 1901, registered under the number RNA: W062017668 / SIREN: 910066117, with headquarters at 55 boulevard Victor Hugo 06000 Nice, represented by its president, Mrs Christine Gastaud.

The aim of the Competition is to perpetuate the musical legacy of Samson François and to enable brilliant young pianists to launch an international career.

Participation in the Contest implies full acceptance of these Regulations (hereinafter referred to as "the Regulation").

The financial terms of participation in the Competition are described in article 2.3 Registration fees.

Article 2- Participation

The competition will take place at the Hippodrome de la Côte d'Azur in Cagnes-sur-Mer from Saturday June 28 to Tuesday July 1, 2025 under the conditions set out in these rules.

Candidates can choose from 5 categories:

- Young Artist" category
- Junior" category
- Young Talent" category
- Children" category
- Young Children" category

The competition timetable is set out in article 3.2 of the rules.

2.1 - Terms of participation

The Competition is open to pianists of all nationalities, in the following age categories:

- Young Artist category (aged 20 or under - born after July 2, 2004)
- Junior category (15 years or under - born after July 1, 2009)
- Young Talent category (aged 12 or under - born after June 29, 2012)
- Children's category (10 years and under - born after June 27, 2014)
- Young Children category (8 years or under - born after June 27, 2016)

It is recommended to register in the category corresponding to your age. Candidates may enter one or more categories.

It is forbidden for a regular student of one of the jury members to enter the competition in the Young Artist, Junior and Young Talent categories.

Students who have taken masterclasses or occasional private lessons are not considered regular students.

2.2 - Program conditions

Program conditions depend on the category chosen by the applicant.

2.2.1 For the "Young Artist" category (maximum age 20)

a - Video preselection :

Free program of minimum 10 minutes and maximum 12 minutes, comprising 2 works from different periods and in contrasting styles, to be submitted by May 1, 2025.

Video recording conditions :

- It's important to pay particular attention to the quality of the video recording. The video must be produced without cuts, in a fixed shot, with the candidate's face and hands clearly visible at all times, and without special effects such as zooms and the like. Preference should be given to sound quality.
- Any type of editing or manipulation of audio and video is forbidden and may result in disqualification.
- The two (2) works can be recorded at different times and then assembled into a single video, or it can be recorded entirely without a break between one piece and the other. It is also possible to submit parts of works individually, for example the 1st movement alone of a sonata...
- All videos must be recent (2023/2024/2025).
- The video is not necessarily intended to be recorded in a professional studio, but can also be recorded in a domestic environment.
- By submitting your entry, you automatically authorize the contest organization to use this video for purposes related to the contest: sending the videos to the jurors and publishing the videos on the site and on social networks.
- Recordings must be sent to the competition email address: samsonfrancoiscompetition@gmail.com with a Youtube or Vimeo link, or using file transfer tools, for example. In all cases, the name of the file or link must include the candidate's first and last name.

24 candidates will be selected for the live test on Tuesday, July 1, 2025 in Cagnes-sur-Mer. The shortlist will be announced on Sunday May 18, 2025.

b - Live test :

Free program of 15 to 18 minutes, including a work by Chopin.

Only one piece played in the video pre-selection may be played again in the live event.

The program provided is subject to change until June 1, 2025. Requests for program changes should be sent by e-mail to samsonfrancoiscompetition@gmail.com. No program changes will be accepted after this date.

2.2.2 For the "Junior" category (maximum age 15)

- **Program:** Free program of 12 to 15 minutes.
- **Pre-selection:** The first 32 registrants will be selected.

The program provided is subject to change until June 1, 2025. Requests for program changes should be sent by e-mail to samsonfrancoiscompetition@gmail.com . No program changes will be accepted after this date.

2.2.3 For the "Young Talent" category (maximum age 12)

- **Program:** Free program of 7 to 10 minutes.
- **Pre-selection:** The first **40** registrants will be selected.

The program provided is subject to change until June 1, 2025. Requests for program changes should be sent by e-mail to samsonfrancoiscompetition@gmail.com. No program changes will be accepted after this date.

2.2.4 For the "Children" category (10 years maximum)

- **Program:** Free program from 4 to 7 minutes.
- **Pre-selection:** The first **40** registrants will be selected.

The program provided is subject to change until June 1, 2025. Requests for program changes should be sent by e-mail to samsonfrancoiscompetition@gmail.com. No program changes will be accepted after this date.

2.2.5 For the Young Children category (maximum age 8)

- **Program:** Free program of 5 minutes maximum
- **Pre-selection:** The first **40** registrants will be selected.

The program provided is subject to change until June 1, 2025. Requests for program changes should be sent by e-mail to samsonfrancoiscompetition@gmail.com. No program changes will be accepted after this date.

2.3 Registration fees

The registration fee depends on the category and must be paid via the procedure described on the Competition page: <https://samsonfrancoispianocompetition.com/en/junior-inscription/> .

- Young Artist" category: €80
- Junior" category: 70€
- Young Talent" category: €60
- Children's category: 50€
- Young Children category: 40€

It is recommended to register in the category corresponding to your age (see paragraph: "2.1 Terms of participation"). Candidates may enter one or more categories.

Applications will only be accepted once the full registration fee has been received. Any bank charges or transfer fees are the responsibility of the applicant.

No claims will be accepted and the registration fee will not be refunded under any circumstances, except under the conditions of Article 11 - Force majeure.

2.4 Application validity

Closing date for entries is :

- For the "Young Artist" category: **May 1, 2025 at midnight GMT +1**
- For the "Junior" category: June 1, 2025 at midnight GMT +1
- For the "Young Talent" category: June 1, 2025 at midnight GMT +1
- For the "Children" category: June 1, 2025 at midnight GMT +1
- For the "Young Children" category: on June 1, 2025 at midnight GMT +1

Candidates must register online (<https://samsonfrancoispianocompetition.com/en/junior-inscription/>), sending the following supporting documents:

- Copy of identity card or passport
- A curriculum vitae in English or French
- A recent high-resolution photo
- If you have not already signed these Regulations electronically and paid the registration fee, you must sign these rules.

For an application to be valid, it must include all of the elements below and, for the "Young Artist" category, the video link, before the closing date for entries to the competition. Incomplete entries will be rejected.

Article 3 - Competition procedure

3.1 Contest announcement

3.2 Competition timetable

The events are open to the public and admission is free.

The competition takes place according to the following schedule:

- **Saturday June 28 and Sunday June 29, 2025:** "Young Children", "Children" and "Young Talent" categories
- **Monday, June 30, 2025:** "Junior" category competition
- **Tuesday, July 1, 2025:** "Young Artist" category competition

This schedule may be adjusted by the Association.

Working pianos will be made available to candidates at the Hippodrome de la Côte d'Azur. The schedule will be communicated by e-mail in June 2025.

3.3 Jury - Selection of winners

The jury is responsible for selecting the winners.

The jury is made up of international personalities from the world of music. The composition of the jury is available on the Competition website: [Samson François International Piano Competition](https://samsonfrancoispianocompetition.com/).

In the event of a tie, the jury chairman has the casting vote. Jury decisions are final and binding.

The jury may interrupt the performance of a work if it considers the competitor's playing to be inadequate, or if the maximum duration imposed for the round is exceeded.

Article 4 - Prizes awarded

The jury is not obliged to award all prizes, but reserves the right to award special prizes or to share prizes.

The list of prizes awarded to the winners depends on the category and is as follows as of December 31, 2024:

- **Young Artist" category: €2,500**
 - 1st Prize: €1,500
 - 2nd Prize: €700
 - 3rd Prize: €300

- **Junior" category: €1,500**
 - 1st Prize: €800
 - 2nd Prize: €500
 - 3rd Prize: €200

- **Young Talent" category: €400**
 - Absolute 1st Prize: €400
 - 1st Prizes and Diplomas
 - 2nd Prizes and Diplomas

- **Children" category: €150**
 - Absolute 1st Prize: €150
 - 1st Prizes and Diplomas
 - 2nd Prizes and Diplomas

- **Young Children" category: €100**
 - Absolute 1st Prize: €100
 - 1st Prizes and Diplomas
 - 2nd Prizes and Diplomas

Special prize for the best interpretation of Chopin: 300€. This prize will be awarded to one of the candidates in any category.

All participants will receive one of the prizes, along with diplomas and surprise gifts.

All candidates may request a certificate of participation in the competition.

Article 5 - How prizes are awarded

Prizes will be awarded :

- **Sunday, June 29, 2025 after the end of competition** for the "Young Children", "Children" and "Young Talent" categories
- **Monday, June 30, 2025 after the end of competition** for the "Junior" category
- **Tuesday, July 1, 2025 after the end of the competition** for the "Young Artist" category

All candidates, accompanied by a parent or guardian in the case of minors, are recommended to attend.

Article 6 - Travel and accommodation expenses

Candidates are responsible for their own travel and accommodation expenses.

Article 7 - Image rights

Candidates must agree to any interviews, videos or promotional meetings related to the Contest.

The Association reserves the right to make or authorize audio or video recordings and to take photographs throughout the competition and during the closing ceremony. It also reserves the right to preserve and communicate these for the benefit of the Association, and to retain ownership of them.

By entering the Contest, candidates authorize the Association, free of charge, to use their surname, first name(s), image and, where applicable, any other attributes of their personality, exclusively for the purposes of communication relating to the Contest, by all digital and/or analog processes, on all media, worldwide and for a period of fifty (50) years from the start of the Contest.

Article 8 - Official version of the rules

These regulations are written in French and English. **Only the French version is binding.**

Article 9 - Protection of personal data

As part of the organization of the Competition, the Association may collect and process personal data from candidates and, where applicable, their parents and/or legal guardians.

The Association undertakes to ensure that the processing of personal data thus carried out complies with current regulations on the protection of personal data, in particular the General Data Protection Regulation (RGPD) 2016/679 of April 27, 2016 and the French Data Protection Act no. 78-17 of January 6, 1978 as amended.

What are the purposes of this data collection?

The collection of this data is necessary for :

- Consideration or rejection of candidates' entries to the Competition
- Where applicable, to inform winning candidates individually and on the Association's website.
- Obtaining the necessary authorizations from the person(s) exercising parental authority for candidates
- Handling requests and questions sent by e-mail to the Association
- To the awarding of prizes to the winners.

What data is involved?

- For applicants :

Candidates are hereby informed that the following personal data is collected by the Association for the purposes of the Competition: surname, first name, pseudonym where applicable, title where applicable, e-mail address where applicable for candidates aged 15 and over, date of birth, category in which the candidate is taking part. This data is collected when the form is sent, as part of the candidate's authorization to take part in the competition, completed by the person(s) exercising parental authority over the minor. The Association also collects the postal address of the minor candidate as part of the authorization provided by the person(s) exercising parental authority.

- For persons exercising parental authority :

The person(s) exercising parental authority are hereby informed that the following data concerning them will be collected by the Association: their surname, first name, if applicable title, date of birth, e-mail address, cell phone number, postal address and parental relationship with the minor candidate (if exercising parental authority). This data is collected within the framework of the authorization to participate in the Contest filled in by the person(s) exercising parental authority.

What are the legal bases for this processing?

The legal basis for the processing of personal data by the Association is the consent of the person(s) exercising parental authority for candidates.

Who receives this data?

All personal data collected by the Association is intended for use by its departments.

How long is this data kept?

This data is deleted at the end of the competition, unless it is kept for a longer period of time, as may be necessary for the management of a dispute, with the exception of the identity and, where applicable, the pseudonym of candidates in order to respect their right to paternity, and with the exception of the data of candidates who are minors and of the person(s) exercising parental authority, which is (are) kept for the legal period of prescription and then archived.

Other information about these treatments :

The Association undertakes to implement and enforce the security measures it deems necessary to ensure the confidentiality of the data collected for the time necessary for their processing, in accordance with the aforementioned French Data Protection Act. Data processing does not involve automated decision-making. No data is transferred outside the European Union.

What are your rights?

In accordance with the French Data Protection Act no. 78-18 of January 6, 1978, as amended, the person or persons exercising parental authority in the case of minors may access, rectify, request the deletion of or oppose the processing of data concerning them. Certain data is, however, essential for taking into account participation in the present Contest and for awarding prizes to the winners.

To exercise these rights or for any questions about the processing of their data in connection with the Competition, applicants should contact the Association's Data Protection Officer at the following address: contact@lesnocturnesdupiano.com , specifying the purpose of the request and providing proof of identity by any means.

The person or persons exercising parental authority in the case of under-age candidates are informed of their right to lodge a complaint with the CNIL if, after contacting the Association, they feel that their rights with regard to their data have not been respected.

Article 10 - Insurance and civil liability

The Association is covered by civil liability insurance.

Article 11 - Force majeure

The Association may not be held liable if, in the event of force majeure as defined in article 1218 of the French Civil Code and case law, it is forced to cancel the 2025 edition of the Competition due to health conditions or government regulations, or in the event of an insufficient number of entries.

Article 12 - Applicable law and competent court

The regulations are subject to French law.

Any dispute will be brought before the competent court in Nice, after all avenues of conciliation have been exhausted.
